






Sentiment Assessment - Economic Scenario

Compared to 3 months ago, how is your overall sentiment about the **global** economy?




Compared to 3 months ago, how is your overall sentiment about the **Indian** economy?






Sentiment Assessment - Unemployment Rates

Do you think the **unemployment rates in India**, in the next 6 months, will increase?




Do you think the **unemployment rates in Italy**, in the next 6 months, will increase?






Sentiment Assessment - Back to Normal Business?






Sentiment Assessment - The Future of Remote Working






Sentiment Assessment - Will Orders from Clients Increase?










Facing Covid19 - Liquidity

Compared to 3 months ago, during lock-down 1.0, is **realization of receivables** from customers still a major difficulty?




To what extent **liquidity and reserves are a top priority**, compared to 3 months ago, during lock-down 1.0?





How do you assess the availability of **monetary support from Italian** financial institutions and banks?




How do you assess the availability of **monetary support from Indian** financial institutions and banks?









What effect has Unlock 1.0 had on your **purchasing** and **procurement**?




Has availability of raw and semi-finished goods improved since 3 months ago?






Facing Covid19 - Logistics

What effect has the **resumption of intra and inter state transportation** had?




Has the **clearing of goods** for import/export **from customs** improved?





Facing Covid19 - Domestic and International Trade






IICCI Survey - Key Quotes
